The NNIS has stratified the incidence density of nosocomial pneumonia by patients' use of mechanical ventilation and type of intensive-care unit (ICU). From 1986 through 1990, the median rate of ventilator-associated pneumonia cases per 1,000 ventilator-days ranged from 4.7 cases in pediatric ICUs to 34.4 cases in burn ICUs (66).

#### **Guidelines for Prevention of Nosocomial Pneumonia**

It is the responsibility of all health care providers to enact principles of care to prevent health care–associated infections, though not all infections can be prevented. Certain patient risk factors such as advanced age, underlying disease and severity of illness, and sometimes the immune status are not modifiable and directly contribute to a patient's risk of infection.
