Bye Law No 96 to 109 of Maharashtra Co-operative Housing Society Bye Laws. It describes about the Special General Body Meetings, When it should be called, Fixing date, time and place for meeting, Notice of Meeting, Voting right of a member etc.

### Model Bye-Laws of Cooperative Housing Society

A Society may frame its own bye-laws but these by laws of society must not contradict the Societies Registration Act of the concerned state. In most cases, though societies use the model bye-laws that are provided, coupled with the provisions of the Housing Societies and Rules act. Amendments to these bylaws of society are passed from time to time.

### Housing Society Bye-laws and Member Rights

Time limit for holding the AGM and minimum notice period. As per the model bye-laws for cooperative housing societies in Maharashtra, every housing society has to hold an annual general meeting (AGM) of the society, every year, before 30th September. It is the responsibility of the committee of the housing society, to ensure that the AGM is held within the prescribed period.
